Museum Hosts Forum on Exhibit Plans for The Old Courthouse



n March 29th, 65 people attended the exhibit design forum at the Old Court House. Thayer Design, Inc. of Amherst, Virginia, was selected to design the exhibits in 2006 and conceptual plans were shared with the public and their input requested.

The plans call for a large exhibit gallery in the main court room with four smaller galleries to the rear. The exhibits will cover the history of the City from prehistory to present day. Galleries will interpret a variety of topics that include Lynchburg people, sports, military service, education, decorative arts, items made in Lynchburg, river and canal transportation, the tobacco trade, and more.

The Old Court House was built in 1855 and is one of Lynchburg's architectural treasures, standing at the top of Monument Terrace. The building

operated as the City Museum from 1979 until 2000 when a near catastrophic ceiling failure took place on the second floor, necessitating a full restoration that was completed in 2006. Next steps will include finalizing the design and contracting for the exhibit components to be built and installed later this year.

Point Of Honor Update

oint of Honor has been approved for inclusion on Virginia's Civil War Trails. During the Civil War, Colonel Robert Owen and his wife Narcissa lived in the home. Robert was president of the Virginia and Tennessee Railroad and Narcissa was active in the Soldiers Aid Society which provided food, clothing, and other assistance to the troops. During the Battle of Lynchburg in 1864, Union spies visited Point of Honor and Narcissa told the story in her Memoirs published after the war. Point of Honor will be included on the Civil War Trails website and maps; an interpretive marker will be placed in the coming months.

A Virginia Historic Highway Marker for Point of Honor has been created and will be erected at the corner of Rivermont and Victoria Avenues in the coming weeks. Along with the marker comes inclusion on the Department of Historic Resources website and print materials.

A recreated kitchen orchard was recently completed at Point of Honor through a partnership of the Garden Club of Virginia, POH, Inc., the City of Lynchburg, and Tom Burford, one of the foremost scholars on historic apple trees today. In 1996, Tom Burford worked with

Point of Honor on the first plantings of early apple species near the kitchen. Over the years, several fell prey to deer and blight and with the planting of eleven new

specimens by the Urban Forester Klaus Schreiber in January 2007, the kitchen orchard has a full complement of trees, each with their own deer protection.

Elizabeth Dabney Langhorne lived at Point of Honor in 1857 and recorded in her memoirs that behind the house stood: "...some delightful old gnarled fruit trees bending low beneath the weight of fruit and years..." Kitchen orchards were commonly found near the rear of the house with varieties that were early ripening (Summer Rambo), decorative (Lady Apple) or uncommon (Calville Blanc d'Hiver), The Point of Honor recreated orchard contains these and other historically appropriate varieties: Golden Pearmain, Winesap, Roxbury Russet, Albemarle Pippin, and Ralls, a seedling that appeared on Tobacco Row Mountain in Amherst County in the 1780s. The Japanese crossed the Ralls with the Red Delicious in the 1960s to make the internationally popular Fuji apple.



Apples provided not only a readily portable fresh fruit, but cider, dried slices, vinegar, apple butter and sauce—even livestock food. With proper storage the season of use in the 19th century extended from June until March. Point of Honor will interpret the orchard as part of life in Lynchburg in its early years and in the future will offer programs with orchard lectures and tastings, cider making, and other apple-related events.

2007 Lynchburg Commemorative Medal

s part of the celebration marking the 400th anniversary of the founding of Jamestown and the 250th anniversary of the establishment of Lynch's Ferry, the Lynchburg 2007 Committee created a medal by local artist Kenneth Wright to commemorate Lynchburg's founding. The obverse design is a ferryman crossing the James River and bears the legend "Sesqui-Bicentennial—Lynch's Ferry" and the dates 1757–2007. The reverse is a rendition of Monument Terrace.

Struck by OPUS, a mint in Providence, Rhode Island, the medals are done in antique bronze and sell for \$15.00 plus tax. Only 2,000 medals were struck and they can be purchased at the Lynchburg Visitor Center located at the corner of 12th & Church Streets and at Point of Honor Gift Shop, 107 Norwood Street. The Museum System was given the proof copy medal by the Lynchburg 2007 Committee to hold as part of our City's legacy.

Historic Photographs To Be Made Available On Website

hrough a partnership with Mrs. Nancy Marion and Blackwell Press, the Museum's photographic collection will be scanned into a database that can be accessed via the Museum website in the future. The collection totals some 8,000 images.

Categories of images include street scenes, businesses, military units, parades and special events, parks and recreation, schools, Lynchburg residents, postcards, Civil War soldiers, and many others. The project will take some time to complete as each image has to be individually scanned, edited, captioned, and added to the data base.

We are delighted to have Nancy's help in bringing this resource to the community and we will keep the public informed on when the collection will be available.
